PROGRAM IN ART PROVENANCE RESEARCH

Spread out over three two-day sessions in New York City, this unique professional training program in art-related provenance research—the first of its kind ever held in the New York market—will assist the legal community and art market professionals who have an interest in artistic, cultural, and ritual objects that have been displaced through acts of war and genocide between 1933 and 1945, with an emphasis on those items misappropriated during the Third Reich, the Holocaust, and the Second World War. Led by experts in the fields of historical and provenance research, this training program will assist participants in assessing the lawful or illicit ownership of these objects. In particular, it will:

- Examine the methods used to research and untangle the complicated history of ownership of an art object;
- Measure the consequences of misappropriations and thefts on institutional practices in museums and other cultural institutions;
- Review the history of cultural plunder from 1933 to 1945 and post-WWII policies designed to return looted art objects to their rightful owners; and
- Discuss the current state of affairs both in the United States and abroad.

SESSIONS:

Every Teaching Unit is composed of two sessions. You *must* attend at least one Teaching Unit. You may *not* register for a single session within a teaching unit or within different teaching units.

Session IV: Friday, April 24, 2015: Plunder during the Holocaust and WWII.

Session V: Thursday, April 30, 2015: The Wartime Art Market: Were All

Session VI: Friday, May 1, 2015: Postwar Restitution Policies and Provenance Research, Present and Future.
